3. In 2007, it was decided to establish ON Co-Labo. Co., Ltd, in order to fully achieve the sales expansion with Textile related business in China, being seized an opportunity to utilize individual dyeing Labo. in China, Shanghai for emerging Chinese Market.
4. Since then, although domestic business in Japan has been continued under the competitive situation and under the separate organizations, by NCC and OG, it was concluded to join forces to developments of Textile related business in global markets through the integration of domestic & overseas activities into new company.
